Award Winning Internationally Exhibiting Artist

(Award Winning) Digital Artist Simon McKeown's work has connected with audiences of millions across the globe. His major work Motion Disabled was showcased at the Smithsonian in Washington D.C. and later synchronised worldwide on the 3rd December, UN International Day of Persons with Disabilities, in 20 countries and 25 locations, including at the UN in New York.

Specialising in in large scale outdoor performative and digital works, McKeown collaborated on Prometheus Awakes in 2012, invited by Bradley Hemmings, Co-Artistic Director of the 2012 Paralympics opening ceremony. In 2015 McKeown closed the centre of Cork City, Ireland to present a ingeniously presented and disability led massive outdoor event entitled Cork Ignite as the prime event of Culture Night Ireland. 7-10,000 people attended the event, which was live streamed and accessible to a diverse audience. His interest in heritage has connected with 30 million people across the globe, working with BBC Four, Channel Four and the World Service.

Mikhail Karikis is an artist and a researcher with an established international profile, working and exhibiting regionally, nationally, and worldwide. His work in film, performance, sound, and installation develops through site-specific collaborations with diverse communities including retired and unemployed people, children and young adults, persons with disabilities and their carers. Culminating in ambitious participatory projects that reach large audiences through exhibitions, television/radio broadcasts, festival screenings, publications and online events, the themes of his works explore ecology and economic legacies, labour histories, social justice and narratives of collective resilience, dignity, and care.

Shortlisted for Film London's Jarman Award (2016 and 2019), Karikis himself sits on leading selection panels supporting emerging talent, including The Platform Graduate Award with Modern Art Oxford, Turner Contemporary, Milton Keynes Gallery, Aspex Gallery and Phoenix Studios. He further nurtures and supports younger art and design practitioners through mentoring, teaching, and collaborations.

Sarah is a founding director of Asia Triennial Manchester, the UK's largest biennial dedicated to engaging Asian communities, 2018 edition generating £4.8m in economic activity. Sarah was inaugural Artistic Director for HOME, Manchester; a £25million cross-art-form centre opened in 2015, developing a major programme of commissions, exhibitions, festivals, and publications for the first three years.

One of Creative Review's 50 Creative Leaders of 2017, Sarah's visual art career has included curator of exhibitions with Turner Prize nominated or winning artists including Phil Collins, James Richards and Gillian Wearing, and is currently working with artists including Judith Barry and Zina Saro Wiwa. In film, Sarah has produced award winning features including Island of the Hungry Ghosts (best documentary, Tribeca), set up Feature Expanded to develop debut films and currently programmes Experimenta for BFI London Film Festival. In September 2020 she visited the Arctic with Greenpeace, highlighting the second lowest sea ice minimum and doing the most northerly youth strike ever.

Climate Action North also has a new STEM project in development which will engage with primary and secondary level students to develop an outdoor area where scientific study can take place to demonstrate the effects of species extinction in the ecosystem and climate emergency. 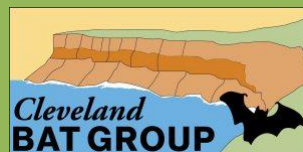

Climate Action North is run by Sharon Lashley, Jennifer Clair Robson and Julie Harrison taking action in the climate emergency through a range of projects including Pollinator Parks, Global Wilders, Wear and Tees Action for Rivers and encouraging communities, businesses and individuals to be inspired to make One Small Change to help the climate and biodiversity crisis.



The Cleveland Bat Group is a voluntary organisation set up in 2017 by Tees Valley Wildlife Trust and the Bat Conservation Trust. The Heritage Lottery Project funded the East Cleveland Batscape project which led to the formation of the Cleveland Bat Group. There are more than 100 local bat groups in the UK. Bat groups are made up of dedicated volunteers and are the mainstay of bat conservation in the UK, undertaking vital front-line conservation work.



Discover Brightwater is a programme of events, projects and activities over the next couple of years to restore, reveal and celebrate life around the River Skerne. This area, in the historic south County Durham, stretches north from Darlington and includes the towns and villages of Newton Aycliffe, Sedgfield, Bishop Middleham, Fishburn and the Trimdons up to Hurworth Burn reservoir.

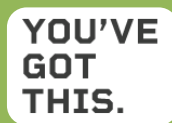
