<p><b>SP/02.04.20</b></p>	<p><i>Call for information on new/emerging projects</i>          Salters gill – possible strategic project in this waterbody, there was interest across the group to work on this together rather than having separate projects.</p>	
<p><b>SP/03.04.20</b>  <i>New/emerging projects</i></p>	<p><i>Catchment Sensitive Farming Project</i>          Led by natural England, targeted where nutrient runoff and silt would be a problem. NE was not a target area due to this. They took on an additional air emissions role to target this which will increase the areas that qualify in Tees Valley. However, it is looking like we will only be getting one additional officer for the North East Area.</p> <p><i>Northumbrian Water Blue spaces scheme</i>          Looking for opportunities for projects across years 3-5. Identifying opportunities through Northumbria and Essex. Have mapped accessible water spaces and then look for projects in that area. Can also fund things as a package of improvements but need it to deliver improvements in the area. More info here</p> <p><i>AMP7 projects delivering water quality improvement in Goose beck, Lustrum beck, Long Newton and other areas.</i></p> <p><i>PR24 planning process for water companies to plan AMP8 for 2025. Will probably have the plan ready in about a years time. Collecting data either side of the treatment works and asking for input to this from external partners particularly on environmental investment. Would it be useful to have a workshop on this?</i></p> <p><i>Consultation on River Basin plans</i>          The consultation for the river basin plan is open until the 22<sup>nd</sup> of April 2022, you can find the consultation here. 25% of water courses are at good status, the government want to get to 77% by ...</p> <p>Flood risk management consultation that runs to ... Jan 2022 which is a non-statutory plan you can find this here. Have put some work into the data viewer for this project.</p> <p><i>NRN Conference 2022</i>          The Nature Recovery Network will be having their first annual conference on the 29<sup>th</sup> &amp; 30<sup>th</sup> of March 2022 in Tees Valley.</p> <p><i>Stockton Tree initiative</i>          Have multiple pots of funding to deliver planting schemes and raising the awareness of the importance of trees and hopefully also incorporating better management of existing sites. May not be a strategic project to start with but could become one over time.</p> <p>TVWT have some money for woodland planting in Stockton and some woodland that needs better management so this could be involved in this.</p> <p><i>Flood risk management authority</i>          Has £36 million in Tees Valley.
